

Cut back on Road Salt to Protect Our Infrastructure, Water, and Aquatic Wildlife!

The Twin Cities Metro applies 350,000 tons of road salt every year, but have you ever wondered where it goes when winter ends?

Stormwater and snowmelt carry dissolved road salt into lakes, streams, and groundwater when winter thaws out. Chloride, a major part of road salt compounds, is especially stubborn in water. Once it dissolves, there is no feasible method to remove chloride from water, and stormwater treatment solutions like stormwater ponds and rain gardens are ineffective at removing chloride. Instead, chloride gradually accumulates in our water bodies, harming fish and other aquatic life. The corrosive nature of road salt also contributes between \$350 million and \$1.2 billion in infrastructure costs each year to the Metro area alone.

What can you do about it?

Here are some helpful tips **you** can use to make your driveways and sidewalks safer and better for the environment this winter:

Shovel!

Salt is never a substitute for shoveling. Shovel your snow and ice first so that salt is only used for melting ice stuck to the ground.

Scatter!

Did you know you only need a 12-oz. mug of salt to effectively de-ice a 20-foot driveway or 10 sidewalk squares? When applying salt, aim to leave 3" between grains.

Salt!

Traditional salt (sodium chloride) does not melt ice when the temperature is below 15 degrees Fahrenheit. Use a low-temperature alternative such as magnesium chloride or calcium chloride to melt ice at lower temperatures or use sand for traction.

Sween!

Sweeping up leftover salt and reusing it later is a great way to save money and limit the amount of salt getting into nearby waterways

WINTER PARKING RESTRICTIONS

Parking restrictions are in effect and go until April 1st.

***No Parking allowed on City streets between the hours of 2 AM and 6 AM without an emergency parking permit issued by staff at City Hall.

***No Parking on any street after a snowfall with accumulations of 2 inches or more until all snow, ice and similar debris have been removed from the paved portion of the street.

*** It is illegal to remove snow from private property and place it on the road or sidewalk.

***Approximately 200 accidents occur each year involving snow moving equipment, so be extra cautious and always give the plow truck the benefit of the doubt. It weighs in excess of 50,000 lbs. Your car weighs about 3,000 lbs.

It's time to get back to the basics of good recycling

The advent of single stream or putting all your recycling in a cart led many people to recycle more than they ever had before. But having a big cart to throw everything into has led to higher contamination in the recycling. Let's get back to basics and clean up our recycling habits.

The fact is that some recycling actions make a bigger impact than others. Please remember these three basic rules the next time you recycle:

- 1. Recycle all empty plastic bottles, cans, paper cartons, clean paper and cardboard boxes. See the list below for acceptable items.
- 2. Remove food debris, liquid, plastic film and greasy or hazardous items from your recycling.
- 3. Place recyclables directly in your cart. Do not bag them. (Paper bags are preferred if you need to use bags.) Return plastic bags to a local grocer or retailer.

You'd be amazed by how big of an impact just following these simple rules can have! There are increasing amounts of non-recyclables being sent to recycling sorting facilities, and every single one of them must be removed by hand or mechanically sorted, or they end up contaminating valuable recyclables. Non-recyclable items placed in recycling containers end up in the garbage, which increases the cost of the recycling process. The right thing to do is put the correct recyclables in the containers and don't hope or wish that the haulers can magically recycle them. Avoid "wish-cycling". When in doubt, throw it out.
