- Natural gas is lighter than air and will rise and diffuse rapidly.

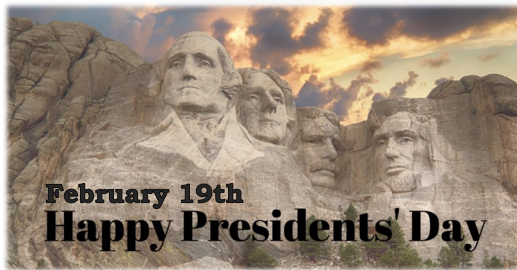

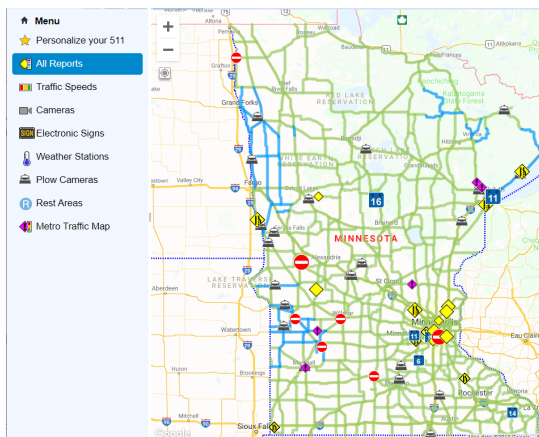

### Cut back on Road Salt to Protect Our Infrastructure, Water, and Aquatic Wildlife!

The Twin Cities Metro applies 350,000 tons of road salt every year, but have you ever wondered where it goes when winter ends?

Stormwater and snowmelt carry dissolved road salt into lakes, streams, and groundwater when winter thaws out. Chloride, a major part of road salt compounds, is especially stubborn in water. Once it dissolves, there is no feasible method to remove chloride from water, and stormwater treatment solutions like stormwater ponds and rain gardens are ineffective at removing chloride. Instead, chloride gradually accumulates in our water bodies, harming fish and other aquatic life. The corrosive nature of road salt also contributes between \$350 million and \$1.2 billion in infrastructure costs each year to the Metro area alone.

#### What can you do about it?

Here are some helpful tips **you** can use to make your driveways and sidewalks safer and better for the environment this winter:

#### Shovel!

Salt is never a substitute for shoveling. Shovel your snow and ice first so that salt is only used for melting ice stuck to the ground.

#### Scatter!

Did you know you only need a 12-oz. mug of salt to effectively de-ice a 20-foot driveway or 10 sidewalk squares? When applying salt, aim to leave 3" between grains.

#### Salt!

Traditional salt (sodium chloride) does not melt ice when the temperature is below 15 degrees Fahrenheit. Use a low-temperature alternative such as magnesium chloride or calcium chloride to melt ice at lower temperatures or use sand for traction.

#### Sweep!

Sweeping up leftover salt and reusing it later is a great way to save money and limit the amount of salt getting into nearby waterways

## WINTER PARKING RESTRICTIONS

**Parking restrictions are in effect and go until April 1st.**

**\*\*\*No Parking** allowed on City streets between the hours of 2 AM and 6 AM without an emergency parking permit issued by staff at City Hall.

**\*\*\*No Parking** on any street after a snowfall with accumulations of 2 inches or more until all snow, ice and similar debris have been removed from the paved portion of the street.

**\*\*\* It is illegal** to remove snow from private property and place it on the road or sidewalk.

**\*\*\*Approximately 200 accidents** occur each year involving snow moving equipment, so be extra cautious and **always** give the plow truck the benefit of the doubt. It weighs in excess of 50,000 lbs.

Although we haven't had to worry about it much this winter (yet), remember, it is against the law to remove snow and ice from private property and deposit it on any roadway

### Do you own a Business or Rental Property in the City of Lexington?

City ordinance requires that all businesses & rental properties obtain a license to operate within the city limits.

Business licenses must be renewed yearly by June 30th.

Rental properties are licensed on a biennial basis from the date of your 1st application. They also require an inspection of the property be done with each renewal.

### Garbage Cart Placement

Snowplow crews rely on residents' help to place garbage, recycling and yard waste carts behind the curb when it is trash pick-up day. Carts placed in the street interfere with snowplowing operations. Crews are unable to plow the streets from curb-to-curb when carts are in the street.

If trash / recycling pickup day coincides with plowing activities, make sure your trash can and recycling bin are well behind the curb or in the driveway so the plow & the snow pushed up from the plows will not hit them.

### Food and Beverage Containers

What is Recyclable:

Only plastics #1 PET, #2 HDPE and #5 PP are recyclable – no black plastic or plastic bags/film

Paper food cartons – milk, water, juice, broth Aluminum cans – leave metal tabs on cans Steel food cans – pinch metal lids inside of food cans

Glass bottles and jars – throw away plastic caps and recycle metal lids separately

Any loose items, smaller than your fist, will not be captured by the recycling equipment. That is why they need to be attached or enclosed within larger containers of the same material. The only exception to this is plastic caps on paper cartons. Caps are allowed by the carton recycling industry.

Preparation Guidelines:

Pour out liquids

Rinse out food debris

Replace caps on plastic bottles and paper cartons

Plastic cups and tubs, replace lid only if it is the same number

Remove plastic overwrap

Throw away plastic caps on glass

Pinch metal lids inside of food cans

### Mixed Paper and Boxes

What is Recyclable:

Newspaper and inserts, Catalogs and magazines, Unwanted mail, School papers

Phone books, Dry goods boxes – cereal, cracker, cake, cookie, facial tissue Toilet paper paper towel inner cores

Preparation Guidelines:

Mixed paper (newspaper, magazines, unwanted mail and school papers) – remove any plastic bags/film and promotional items; windowed envelopes are fine. Mixed paper can be placed in a paper bag Attach small Post-It notes to larger paper

Dry goods boxes – remove plastic bags or other packaging Flatten boxes



### Corrugated Cardboard

Preparation Guidelines:

Flatten, Keep clean and dry

Clean = free of grease, dirt and other contaminants

Shipping boxes – remove any non-paper packaging e.g., styrofoam™, plastic inserts, excessive tape, plastic bags or wrap.



### Can I recycle my delivery PIZZABOX?



**To go/delivery pizza boxes**, if the top of the box is clean and the bottom is greasy, tear the top off and recycle that. If you are signed up for the Anoka County organics program, the greasy bottom can be composted, make sure all stickers or plastic/waxy liners are removed.
