6. ACTION ITEMS:

A. Recommendation to approve Resolution NO. 14-26 A Resolution Approving Minor Combination For 8720 Syndicate Avenue, Lexington, MN

Petracek explained that the property owner's wanted to combine the two adjoining lots that they own for tax purposes, and with the intention of possibly lowering their assessment. Discussion ensued.

Motion was made by Councilmember Payment, seconded by Councilmember Bailey to approve Resolution NO. 14-26 – A Resolution Approving Minor Combination for 8720 Syndicate Avenue, Lexington, MN. Passed unanimously. Motion carried 5-0.

B. Anoka County Fire Protection Council Joint Powers Agreement

Fire Chief Gary Grote provided an overview of the Anoka County Fire Protection Council Joint Powers Agreement (JPA). He explained that the JPA is a legal agreement with Anoka County cities that will allow the organization to acquire property, purchase a CAD system, and form the new fire academy. He further explained that the bylaws will control what will happen within the JPA agreement and stated that the City of Lexington will pay between \$700 - \$800 and dues, which would equate to about 1.5% of the cost to operate the JPA. Chief Grote provided explanation to the governance of the JPA.

Councilmember Bailey asked Chief Grote why the City's payment for 2015 is so much less than the 2016 payment. Grote responded by saying that a grant was going to cover the first year of the JPA's agreement. Discussion ensued.

Attorney Glaser provided further explanation of the voting structure that wouldn't allow the larger cities in the JPA to control the vote or the finances. Discussion ensued.

Motion was made by Councilmember Bailey, seconded by Councilmember Payment to approve Anoka County Fire Protection Council Joint Powers Agreement. Passed unanimously. Motion carried 5-0.

Mayor Pitchford and Councilmember Bailey thanked the Lexington residents for allowing each of them to serve the community. Mark Kurth, Mayor Elect, presented Mayor Pitchford and Councilmember Bailey a plaque and thanked them for their years of service to the City of Lexington.
