APPEALS HEARING: HEARING TO APPEAL DESIGNATION AS A POTENTIALLY DANGEROUS DOG, by Kayla Zelasney

Vice Mayor Plasch called to order the Appeals Hearing to Appeal Designation as a Potentially Dangerous Dog of the City of Lexington of September 4, 2014 at 7:00 p.m. Councilmember's present: Bailey, Hughes, and Payment. Absent: Mayor Pitchford Also Present: Bill Petracek, City Administrator; Tina Northcutt, Finance Director; Kurt Glaser, City Attorney; Officer Lucas Fredrickson and Sergeant Pat Aldrich, Centennial Lakes P.D.; Kayla Zelasney, Resident; Tim & Lori Glover, Bistro LaRoux Owner's.

Administrator Petracek provided a brief explanation to the appeal that was filed by Kayla Zelasney of the designation of her dog "Diesel" as a potentially dangerous animal. Attorney Glaser explained the city ordinance on "designating an animal potentially dangerous." He suggested to proceed with the hearing that the police department presents the facts and then Ms. Zelasney would provide testimony on behalf of Diesel.

Centennial Lakes Police Department Community Service Officer, Lucas Frederickson provided an explanation as to why Diesel has been declared a potentially dangerous animal. Discussion ensued.

Kayla Zelasney, 9334 Dunlap Ave, Lexington, MN. approached the Council and provided testimony on behalf of her dog, Diesel. Discussion ensued.

Discussion was had about the picture that was taken by the PD, but not available in the packet of information provided. Sergeant Aldrich stated they would go to the police department and send the picture over by email for the Council to view.

A motion was made by Councilmember Payment, seconded by Vice Mayor Plasch to reopen the Appeals Hearing to Appeal Designation as a Potentially Dangerous Dog at 7:44 pm. Passed unanimously. Motion carried 4-0

Officer Frederickson provided an explanation to the picture which showed the bite mark that was caused by Diesel – a copy of the picture was provide to the City Councilmembers. Kayla Zelasney also provided an explanation to the picture of the dog bite. Discussion ensued.

A motion was made by Councilmember Bailey, seconded by Vice Mayor Plasch close the Appeals Hearing at 7:51 pm. Passed unanimously. Motion carried 4-0.

A motion was made by Councilmember Bailey, seconded by Vice Mayor Plasch to rescind the potentially dangerous dog designation on Diesel. Passed unanimously. The motion carried 4-0.
