Re: New Service Roads and Address Change

The construction of the new service roads along Lake Drive will require us to make some changes to the current addresses along the new streets. With the new construction, almost all of the properties with Lake Drive addresses are located on the new frontage roads rather than Lake Drive. We are recommending that all of the properties along the new streets have the same street name to provide for more accuracy, consistency, and uniformity.

#### Our recommendation is:

- 1. All properties on the north side of Lake Drive, from Restwood Road to Lexington Avenue, will be located on North Highway Drive, since all of the other properties already have North Highway Drive as their current address.
- 2. All properties on the south side of Lake Drive, similarly, has a few of the businesses on the south side of Lake Drive that would be changed to South Highway Drive.

We have consulted with the Post office and the City Engineer, as well as looked at all the necessary steps to make this transition as smooth as possible and to limit the negative impact the address changes will have on the businesses and residents that are affected.
