Centennial Lakes Police Department Services Provided to the City of Lexington

QUALITY OF LIFE:

- -Community Service Officers = Non-sworn, civilian para-professionals who address code enforcement and ordinance violations. CSOs also provide extra patrol to parks and neighborhoods. In addition, they perform animal control duties including handling animal bites, transporting stray and found animals, addressing nuisance animals and related complaints, etc. All provided as part of service to the community.
- -Special Attention/Problem Issues = We address without charge-back to the City various special enforcement actions to address drug activity, disorderly houses, ordinance violations, nuisance complaints, etc.
- -Medical Response = Our officers have saved lives and lessened impact of medical issues due to quick response to medical emergencies.
- -Citizen Interaction and Connection = Both routine and through programs like Citizen Academy.
- -Our services are not prorated, i.e. we perform all of these functions as part of our overall service to the City.
- -Citizen Opinion Survey = Strong support for our Department and the services that we provide.

PROTECTION OF LIFE AND PROPERTY:

- -We provide home and vacation checks free to our citizens.
- -Vehicle and residential lock-outs are free to public.
- -Commercial Vehicle Inspections = revenue for the City and increased safety for driving public.
- -24/7 patrol of neighborhoods and businesses.

COMMUNITY ENGAGEMENT AND IDENTITY:

- -School Liaison = Officers work with at-risk students who reside in Lexington.
- -Vested interest = Our officers reflect a strong and vested interest in the safety and stability of the community.

- -Local Police Station = Easily accessible for citizens and close to Lexington for emergency response.
- -Community Relations = Night to Unite, Citizen's Academy, Safety Presentations are provided without charge.
- -Special Events = We provide traffic control and support for parades, runs, festivals, special events without charge-back to the City.

COST EFFECTIVE:

- -We do not charge the City for extra or additional staffing when needed, or for extra patrol, or policing of special events, or code enforcement, or animal control, or school liaison, or problem-solving, etc.
- -Background checks and liquor law training and inspections are done without charge-back to the City.
- -Liability = Few citizen complaints, no law suites, quality personnel and policies.
- -Budget = Less cost to the City in recent years because of funding formula. Department has also been under budget in recent years.
- -Outside Funding = Sizeable funds received from forfeitures and seizures coming from our work with IRS and DEA. We also participate in DWI and Drug forfeitures in much the same manner. These funds are returned to the Department which helps to defray cost to the City.
- -Community Emergency Response Team (CERT) = Department coordinates CERT team for special events and emergency situations at no cost to the City.

MISCELLANEAOUS:

- -Population Growth = Increase in concentrated population due to new apartment buildings will mean additional policing issues, increased traffic, and require proactive and preventive measures (including crime-free multi-housing). Our approach to policing has deterred problems from escalating.
- -24/7 Service Function = We provide 24/7 staffing, patrol, and focused problem-oriented policing without additional charge to the City.

IMPORTANT REMINDERS:

- -We compare favorably with other cities of comparable size in terms of cost and effectiveness. Must be careful also to compare "apples to apples" in terms of population density, calls for service, bars, rental housing, traffic, etc.
- -Lexington Citizen Opinion Survey = Reflected strong support for our Department and satisfaction with our services.
- -Budget = The budget formula has actually worked in Lexington's favor in recent years. Our Department has come in under budget as well.

- -Bar Issues = We have taken a measured approach in holding bars accountable for violations. This approach may not be the same for another agency.
- -Current Joint Powers Agreement/Contract = Withdrawal from current contract allowed only after October of 2021.
- -We provide quality policing in delivery of service, leadership, policies, training, and personnel.
- -We maintain a very strong, vested, and personal interest in the safety, stability, and reputation of the City of Lexington. It is difficult to quantify the results, but it is demonstrated in the manner in which we address problems and safety issues. I am confident that our approach to policing has deterred problems from escalating and will continued to do so. To do anything otherwise may compromise or sacrifice levels of citizen satisfaction, service, response, deterrence, problem-solving, etc.
- -Local control of policing granted through our JPA.
- -Other types of contracted service could rise arbitrarily.
- -The City of Forest Lake recently went through a suggestion to change its law enforcement services. It caused considerable upheaval and consternation in the Community. The City ultimately retained its police department. The City is still healing from this controversy.
