A word from our Mayor Mark Kurth,

I'll start off wishing everyone a very Happy and successful New Year. Thank you for allowing me to serve you and the City of Lexington this past year. It is an honor that I do not take lightly. I'm very proud of our city, our city staff, our city council members and what we have accomplished this past year. While we have not always agreed on everything, we have treated each other with respect, courtesy, and professionalism.

The results of the Santa around town were 18 grocery carts of food and \$400 that all go to the local food shelf. Thank you to our fire department that donates their time for this every year, and thank you to everyone that came out and donated. Our 2016 budget is complete, and is posted on our city website for you to review. Our budget increased by \$20,000. With that increase, we put money into savings for roads, technology, public works equipment, a fire station in the distant future, and park equipment. By saving this money now, it will decrease potential borrowing expenses in the future, thus saving money. We have done an extensive renovation in our fire department which should extend the life of the building for many years to come. Other items that were completed in 2015 was extensive strategic planning sessions for the near and distant future, complete renovation of South Flowerfield Rd, extensive discussions with our police, fire, and medical on ways to reduce our public safety dollars, approving rezoning of lots near the mall for redevelopment, putting the Lovell Building up for sale and much more.

For 2016 will focus on items that came out of our strategic planning sessions. The first on the list was to find ways to increase revenue and profits to our municipal liquor store. For those that are not aware, profits from this go directly towards our general fund, thus increased revenue to the city.

I would like to encourage and invite all of you to attend your city council meetings. Feel free to come to us with the good, the bad, and your ideas that you may have for the future of your city.

Free tax assistance is available if you have a lower income, are a senior citizen, have a disability or speak limited or no English.


Most volunteer tax preparation sites are open only from February 1 through April 15.

The following materials are not recyclable at this time in curbside programs throughout Anoka County.

Please do not recycle!

Paper:

- Boxes soiled with food
- Boxes from frozen foods
- Cups
- Egg cartons
- Gift wrap
- Napkins
- Paper towels
- Pizza boxes
- Plates

Glass:

- Containers that held hazardous products, such as nail polish and hobby paint
- Drinking glasses, mugs, dishes, cookware, pottery and vases
- · Window and mirror glass

Metal:

- Aerosol cans
- Containers that held hazardous products, such as paint thinner and automotive fluids
- Paint cans

Plastics:

- Containers that held hazardous automotive and yard products, such as motor oil and pesticides
- · Containers larger than an ice cream pail/bucket
- · Lawn and garden hoses and carts
- Meat trays
- Microwaveable food trays black
- Plastic wrap and bags*
- Styrofoam[®]
- · Toys, pools and slides

*Plastic shopping bags are recyclable at many grocery stores.
