Week in Review

This week saw several crews on site to get the project underway. Listed below are highlights from this week's activities.

Monday 8/24/15

- Removal limits were marked by MSA Professional Services
- Saw cutting was done at marked limits (driveways, cross streets, curb lines) by Hardrives Inc.
- Mailboxes removed and temporary mailbox location established by Herness Construction

Wednesday 8/26/15

- Flowerfield Road reclaimed by the subcontractor All States Pavement Recycling.
- Bituminous and concrete driveways removed by Hardrives Inc.
- Clearing and grubbing of trees near proposed cul-de-sac at Flowerfield Road and South Highway Drive.

Thursday 8/27/15

- Bituminous and concrete driveways removed by Hardrives Inc
- Concrete curb removed by Hardrives Inc.
- Existing storm sewer removed by subcontractor Penn Contracting Inc.
- Proposed storm sewer catch basins and piping staked by MSA Professional Services

Friday 8/28/15

- Bituminous and concrete driveways removed by Hardrives Inc
- Concrete curb removed by Hardrives Inc.
- Existing sanitary sewer cones removed and replaced by subcontractor Penn Contracting Inc.

Tentative Schedule

Below is the Contractor's tentative schedule as it stands after the first week of construction.

Aug. 31 th – Sept 3 rd	-	Storm Sewer Pipe Placement
Sept. 4 th – 8 th	-	Curb and Gutter Paving
Sept. 14 th – 17 th	-	Sub Grade Preparation
Sept. 17 th – 18 th	-	Tolerance Reclaimed Base for Paving
Sept. 21 st	-	Asphalt Base Course Paving
Sept. 22 nd – 24 th	-	Project Site Restoration, Adjusting of Utilities, Driveway Paving
Sept. 25 th	-	Asphalt Wear Course Paving

Driveway Access

After this week's construction activities many residents had their driveway removed. For those that had driveway pavement removed, there should be an in place "ramp" made of soil for you to safely traverse in and out of your driveway. If you feel there is not adequate soil to accommodate your vehicles please let us know.
